**KEY MONITORS:** Inside the throttle cabinet door is a list of paid members. When a person signs in and you don't know for certain that they are members then check the list. If their name is not on the list then they are not paid members. It's pretty simple. We are still having a problem with former members from years back and members who were recently dropped for non-payment showing up and using the layouts.

Also during Open House only members are to be operating trains and the equipment must be finished and in good operating condition. Members (those who have them) must be wearing their name tag.

**APPLICATION AND NEW MEMBER PROCESS.** There appears to be some confusion as to the application process for new members. While this mostly applies to Key Monitors, other members may be put into this position so in a nutshell here's how it is supposed to be handled.

Be it on-line or on paper a prospective member **MUST** first fill out an application. If it's on paper then it can be deposited in the dues box otherwise the on-line applications are processed elsewhere. The applicant will receive a letter from the Board within a few weeks. This gives us time to make sure that the applicant is not carrying any baggage (so to speak) or if there are questions we can address them. It may seem strange but even in a quaint little hobby like ours there are some people of questionable reputations and we need to head them off.

They will be sent a letter giving them information. When the applicant comes down for training **then and only then are we to accept any form of payment for dues.** They are to be given a new member packet at this time. If we are out then leave a note and we'll get one to them.

**WE ARE LOOKING FOR KEY MONITORS.** We know this is getting redundant but we need people in these positions to keep everything operating. Our Key Monitor pool is getting very shallow and we need members to step up and start to fill in the gaps. We're only looking for one or two days a month. If we cannot find people to cover these assignments then our only option is to start closing on certain nights and we do not want that to happen.

**C&NW HISTORICAL SOCIETY EVENT IN CRYSTAL LAKE.** On May 19<sup>th</sup> the C&NW Historical Society is having a meet in Crystal Lake. As in the past we will be running the swap meet at the hotel. **AGAIN.... THROTTLE DEPOSIT. LET'S CLEAR THIS UP FOR THE LAST TIME.** On page 6 of the "Layout Operating Guidelines", which you all should have received, it states that "Members signing out a throttle must leave **a \$5.00 cash deposit** for the throttle with the dispatcher in charge". This is pretty cut and dry, we don't want credit cards, FOID cards, drivers licenses or whatever pocket change you have lying around. There are several reasons that we do it this way. For starters it is meant to remind operators to return their throttle to the key monitor and not go home leaving it lying around. If the operator does not return it then the \$5.00 goes into the cookie jar (thanks in advance for the donation). Secondly in an age of identity theft we do not want to be put in a position to be responsible for anything that may have the potential to lead to such a situation.

Now if maintaining the \$5.00 deposit is proving difficult we do have a few suggestions. If you have a locker or tote keep the money clipped inside. If you use a grey "A-Line" bag or other types of bags then a luggage tag will hold a \$5.00 bill quite nicely. If you use a box then you can tape the money to the inside of the lid. Any way you do it you will always have the required \$5.00 on hand. We do realize that things happen and on a rare waiving this requirement may be in order however this is to be handled on a case-by-case basis by the key monitor in charge.

**WORK NIGHTS.** Tuesday night is work night. The list of "to do" items keeps growing and number of hands we have "to do" them keeps getting smaller. A lot of these items do not require any special skill or knowledge just a willingness to put in the time and effort.

**Electronics people are high on the priority list.** If you have a knowledge of electronics we could really use the help. We have lost several members of the electronics team in the last few months and we cannot expect a handful of members to carry the weight. **UP 4014.** The Big Boy is on tap for a visit to Chicago this summer. Official details have yet to be announced.


**N SCALE.** There continues to be a lot of track and wiring activity. Both branchlines on the 2 peninsulas have temporary wiring in place so all of the bugaboos can get worked out before the permanent installations are secured. The candy company siding is now active.
